Note 2: - By a Special Resolution dated 30th May, 2020, the Articles (now Part A) were adopted as the Articles of Association of the Company in substitution for and to the exclusion of all the existing Articles thereof.

# Part B OVERRIDING EFFECT

- A. The provisions contained under Part B of theRestated Articles of Association shall have an over-riding effect over the respective provisions provided under the Part A of these Restated Articles of Association.
- B. Notwithstanding anything to the contrary contained in Part A of this Restated Articles of Association, unless agreed to otherwise by the Company, VISTRA ITCL (INDIA) LIMITED capacity as in its capacity as trustee of the "HDFC CAPITAL AFFORDABLE REAL ESTATE FUND 1" ("Investor") shall be bound by the provisions contained in the Restated Articles. With regards to the Investor, in the event of any inconsistency or contradiction between the provisions of Part A of the Restated Articles of Association and Part B of the Restated Articles of Association the provisions of the Part B Restated Articles shall override and prevail.

## 1. DEFINITIONS AND INTERPRETATION

Any term capitalised by not defined shall be given the meaning as provided in the Agreement

- 1.1.1 "Applicable Law" means any by-laws, rules, statute, law, ordinance, codes, guidelines, regulation, approval, order, injunction, directive, notices, directions, judgment, or decree issued by any Governmental Authority (as defined in the Agreement) or Person (as defined in the Agreement) acting under the authority of any Governmental Authority;
- 1.1.2 "Closing Date" means the Closing Date as defined under the Investment Agreement entered into between the Company and the Investor on September 10,2020;
- 1.1.3 "Investor" means VISTRA ITCL (INDIA) LIMITED capacity as in its capacity as trustee of the "HDFC CAPITAL AFFORDABLE REAL ESTATE FUND 1".
- 1.1.4 "Agreement" means the investment agreement entered into between the company and the investor on September 10, 2021.



1.1.5 "Competitor" means shall mean any Person engaged, directly or indirectly, in the business of development and/or construction of real estate projects and includes Financial Investor as defined in the Agreement;

#### 2. BOARD NOMINATION RIGHT

- 2.1.1 On and from the Closing Date, the Investor shall have the right to nominate 1 (one) non-executive Director ("Investor Nominee Director") on the Board.
- 2.1.2 The person to be nominated by the Investor for appointment as an Investor Nominee Director shall:
  - (a) not be an employee of a Competitor or any sitting member of the legislative assembly, member of the Parliament and/or ministers holding political office or any Person Controlled by any sitting members of legislative assembly, member of Parliament and/or ministers holding political office; and
  - (b) be an employee of HDFC Group or be a part of any of the boards of the entities within the HDFC Group or any other individual closely associated with, any entity with the HDFC Group (such individual should not be on the board of a Competitor) on a long term basis. It is hereby clarified that advisors, consultants, professionals such as practicing lawyers and accountants who are not closely associated and not in long term association with any entity within the HDFC Group shall not be eligible to be appointed as Investor Nominee Director;
  - (c) It is further provided that the Investor Nominee Director shall continue to fulfil the above criteria until he is a director on the Board of the Company.
  - (d) For the purposes of this Article, it is stated that the term "HDFC Group" shall have the meaning assigned to it under the Agreement.

## 2.2 Appointment and Removal of Investor Nominee Director

- 2.2.1 The right of Investor to nominate the Investor Nominee Director under this Agreement shall include the right to remove or replace, at any time, the Investor Nominee Director, as the case may be, from office as a Director on the Board.
- 2.2.2 In the event that the Investor Nominee Director is removed or replaced under this Article 2.2 or ceases to hold office for any other reason, the Investor shall be entitled to nominate another Director in his or her place, and the Parties agree to procure that he or she is appointed as promptly as practicable, subject to compliance of Applicable Law.
- 2.2.3 In the event that the Investor Nominee Director is required to retire by rotation under Applicable Law, then such Director shall be re-appointed subject to such approvals as may be required under the Applicable Law, at the same General Meeting in which he / she retires, unless otherwise agreed by the Investor, in which case, the Investor, shall replace the respective nominee Director with another nominee Director in accordance with Articles 2.2.4 and 2.2.5 and Applicable Law.
- 2.2.4 To appoint or remove/ replace an Investor Nominee Director under this Agreement, the Investor, shall provide written notice to the Company (with a copy to the other Parties and the concerned Director) to this effect, and upon receipt of such notice by the Company from the Investor, the Company shall procure the appointment or removal/ replacement of such Investor Nominee Director as the case may be, in accordance with such request. The notice shall specify the identity of such Person that is to be appointed or removed as the Investor Nominee Director as the case may be.

#### 2.2.5 The notice referred to in Article 2.2.4 above shall also:

- (a) in the case of an appointment of an Investor Nominee Director be accompanied by a signed written consent from such person agreeing to act as a director and other documents as may be required under the Applicable Law; and
- (b) in the case of a removal/replacement of the investor Nominee Director except where such removal/replacement is not with the consent of the person resigning, be accompanied by a signed written resignation along with any other documents as may be required under the Applicable Law from that person setting out the reasons for resignation and acknowledging that such person has no claim whatsoever against the Company in respect of fees, remuneration, compensation for loss of office or otherwise.
- 2.2.6 No individual shall be required to hold any Securities to qualify as a Director.

#### 2.3 Alternate Director.

At the request of the Investor Nominee Director (the "Original Director"), the Board may appoint an alternate director (an "Alternate Director") who is recommended for such appointment by the Original Director with the consent of the Investor, to act for the investor Nominee Director during his absence, in accordance with the provisions of the Applicable Laws. An Alternate Director appointed under this Article 2.3 shall not hold office for a period longer than that permissible to the Original Director in whose place he has been appointed and shall vacate office if and when the Original Director returns. The act of Alternate Director acting for the Original Director will be deemed to be the act of the Original Director. It is hereby clarified that the Alternate Director shall be eligible to be appointed only if he satisfies the conditions as provided in Article 2.1.1 above and shall be bound by Article 2.1.3.

#### 2.4 Non-Executive Director.

The Inventor Nominee Director nominated by the Investor pursuant to Article 2 above shall be identified as such (to the extent required under Applicable Law) in any filings made by the Company with any Governmental Authority and shall be a non-executive Director. No such Investor Nominee Director shall be responsible for the day-to-day management of the Company and shall not be liable for any failure by the Company to comply with applicable Law or be construed as an "officer in default" (under the Act) or an "occupier" (of the Company's premises) or "assessee in default" or "employer" under Applicable Law.

#### 2.5 Board Committees.

The Investor or the Investor Nominee Director may, from time to time, request the Board or any committee thereof (as the case may be) to: (i) permit appointment of the Investor Nominee Director to any committee or sub-committee of the Board; or (ii) permit the Investor Nominee Director to attend the proceedings of any committee or sub-committee of the Board as an invitee. Thereupon, the Board or any committee or sub-committee thereof (as the case may be) shall, in its sole discretion, approve such appointment or request. In the event that the Investor Nominee Director is appointed on any committee or sub-committee of the Board, then Clauses 2 to 2.4 shall apply mutatis mutandis to meetings of the Board Committees or sub-committees.

### 3. BOARD MATTERS AND PROTECTION MATTERS

## 3.1 Board Matters.

- 3.1.1 The following is the list of Board Matters:
  - (a) Any sale or disposal of the any undeveloped immoveable property (excluding inventory) which is outside the Ordinary Course of Business of the Company.



- (b) Incurrence of any debt by the Company in excess of the amounts which have been approved in the most recent meeting of the Company.
- (c) Changes to the capital structure of the Company, including issuing further interests in the Company to any Person.
- (d) Alteration or substitution of any of the Charter Documents of the Company that adversely affects the rights of the Investor.
- (e) Merger, consolidation or re-organization or entering into a scheme of arrangement or compromise with the creditors or shareholders, or affecting any scheme of arrangement or reconstruction, in respect of the Company.
- (f) Agreeing or committing to do any of the matters set out in items 1 to 6 above.
- 3.1.2 The Company shall not proceed with the Board Matters unless and until these matters have been considered, discussed, approved and authorized by a majority of directors on the Board. In the event any of the Board Matters is undertaken by the Company either through any member(s) of the Board, any shareholders, officers, employees and/or managers, committees, in a single transaction or a series of transactions, directly or indirectly, without a specific authorization by majority of the Board or without these matters being considered, discussed, approved and authorized by the majority of the Board, then prior to proceeding with these Board Matters the Investor shall have the right of affirmative consent on these Board matters.
- 3.1.3 The procedure set out under Clause 3.2.2, as applicable to Protection Matters, shall apply and be followed by the Company for the purposes of procuring the affirmative consent of the Investor or the Investor Nominee Director for the purposes of any Board Matters (to the extent such affirmative consent is required pursuant to Article 3.1.1 above).

## 3.2 Protection Matters.

- 3.2.1 The list of Protection Matters is provided below:
  - (a) Entering into any related party transaction excluding Subsidiaries that (on a consolidated basis) not at an arm's length basis
  - (b) Appointment of statutory auditors of the Company as long as the statutory auditor is not one amongst the Accounting Firms.
  - (c) Applying to the court for bankruptcy or to voluntarily wind up the Company.
  - (d) Entering into any joint ventures by the Company, other than in the Ordinary Course of Business.
  - (e) Agreeing or committing to do any of the matters set out in items (a) to (d) above.
- 3.2.2 Notwithstanding anything to the contrary in this Agreement, none of the Protection Matters shall be approved, acted upon or undertaken by, or in respect of, the Company including by its Board, shareholders, officers, employees and/or managers (whether at a meeting of the shareholders, Board, committees thereof, or by way of resolutions by circulation or otherwise), in a single transaction or a series of transactions, directly or indirectly, without having received the affirmative consent of the Investor or the Investor Nominee Director in the manner set out under Clause 3.2.2 below.



## 3.3 Manner of Approving Protection Matters.

- 3.3.1 Decisions in relation to any Protection Matters shall first be considered by the Board.
- 3.3.2 If any Protection Matter is proposed to be considered by the Board, a written notice of such item together with necessary background information and supporting documents shall be shared with the Investor Nominee Director at least 7(seven) days prior to the Board meeting in which such Protection Matter is proposed to be considered, along with the notice for such Board meeting or along with the materials for the relevant circular resolution. Any resolution proposed to be passed in relation to a Protection Matter in a Board meeting or by way of circular resolution shall be deemed to have been passed or approved only if the Investor Nominee Director has affirmatively voted in favour of that resolution or a written consent in favour of such Protection Matter has been issued by the Investor or Investor Nominee Director to the Board prior to the meeting. In the event that the Investor Nominee Director is not present for a meeting of the Board in which one of the items on the agenda of such Board meeting is the passing of a resolution in connection with a Protection Matter and no prior written consent of the Investor or Investor Nominee Director has been received in connection with such Protection Matter, then the Board shall be entitled to discuss the relevant Protection Matter, provided that no resolutions shall be passed or decision or action shall be taken by the Board in respect of such Protection Matter and the decision in relation to such Protection Matters shall be adjourned to next meeting which shall be convened in accordance with the Articles of the Company. In the adjourned Board Meeting for which one of the items on the agenda is the passing of a resolution in connection with the same Protection Matter, if the Investor Nominee Director is not present and also no prior written consent of the Investor or Investor Nominee Director has been received in connection with such Protection Matter, then the Board shall proceed, discuss, consider and vote on Protection Matter.

#### 4. FALL AWAY OF RIGHTS

All Investor rights set out under this Restated Articles shall fall away in the events as provide in the Agreement.
